Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

PCHA plans to project base approximately 275 vouchers. Currently PCHA partners with Wasatch Behavior Health, Scenic View Academy and the Refuge. All of these partners provide supportive services for persons with disabilities, and victims of domestic violence. PCHA is also going to PVB units for seniors. Most of the clients are already living in the units so the conversion will not cause any relocation of tenants. Goals from the 5- year plan for PHA Plan 2025

Goal: Educate staff and board on the repositioning of Public Housing units.

- Complete an assessment on all Public Housing units in preparation of repositioning.

In early August, PCHA will meet with the Brawner group to discuss PCHA's options for a conversion or a repositioning. Currently PCHA has some single family dwellings that may be appropriate for disposition. PCHA is not interested in decreasing the number of PH units so that will be a consideration when working on a conversion plan. PCHA will create an internal plan and timeline for repositioning.

Once PCHA staff understand and reviewed the options for a conversion we will make decision on how to move forward. PCHA has already evaluated a number of public housing single family dwelling units that would be good to dispose of, but we want to make sure we don't lose units in our community.

Goal: Continue to improve services through increased technology and online services

- Continue to work with software company to add online recertification, interim reviews, and change of circumstances.

PCHA has made progress in using the online application process. With Nspire, HIP and HOTMA, PCHA has opted not to add online recertification yet. PCHA has made progress learning the inspection module such as scheduling. As more online options become available, PCHA will consider options for more online services.

- Move the organization to a "paperless" through the process of document imaging.
PCHA continues to consider options. As technology grows there may be options with in Emphasys software to house tenant documents. There are a couple vendors interested in working with PCHA in the future.

- Educate tenants and HCV clients to use the online services as they become available
More emphasis will put on this goal when we have fully executed HOTMA and Nspire.

- PCHA will review and implement streamline processes approved by HUD.

PCHA has spent a significant time and energy preparing for HOTMA and Nspire. All the staff have attended trainings and conferences with the industry.

- PCHA will look into programs associated with Public Housing Residents increasing personal assets.

PCHA has been discussing “savings” opportunities for families who are participating in the family self-sufficiency program (FSS). The idea is creating a way for participants to save money and bank will match their contributions. If the family completes the program and meets all of their goals, they would have access to all of the funds. If they don’t complete the program and or withdraw, the monies they deposited would be returned to the participant. In 2024, PCHA started offering the FSS program to public housing residents.

Goal: Increase the number of affordable housing units through acquisition or partnerships.

- PCHA will look into the possibility of Project Based Vouchers.
PCHA has started the process of working with HUD to attach Housing Choice Vouchers fund to Utah Regional Housing units. Though the PVB program, we can create designated housing for disabled adults, victims of domestic violence and seniors.

- PCHA will look at options for partnering with other agencies to increase the number of available units.

This will take place over the next 12 months as we entered into partnerships with other agencies. PCHA will be putting out an RFP, inviting local agencies to apply for subsidies through the project based voucher program.

- PCHA along with URH will consider different housing options listed in the Provo City Plans.

PCHA considered partnering with a local group who was developing ADU units. After several meetings it was decided it was not a good fit for PCHA.

- PCHA will continue to look for homeownership opportunities for moderate to low income families.

Utah Regional Housing (URH) created a support organization: Utah Community Land trust (UCLT). UCLT will look for ways to increase the number units for sale. UCLT has met with the City of Provo, Intermountain Hospital and Provo School District to create housing opportunities for city employees, teachers, and hospital staff.
